## **Mayor's Comments**

## **Department Heads**

Attorney Dave Jones stated that he and Village Engineer Steve Darcangelo just received documents for the mayor's signature regarding the dedication of the extension of Rifts Drive in McHarrie Towne and the sanitary sewer easements. A resolution will be needed for this authorization either by phone poll or at the next meeting.

Codes Enforcement Officer Gregg Humphrey noted to residents that if they hire snow plow companies to plow their snow that they must stress to the plow company not to push the snow in a neighbor's driveway/property. The snow must remain at the location or be removed to an off-site location.

## • Formalize Resolutions

## • Communication Plan/Strategy

Trustee O'Donnell stated that the committee met with Dominick from Clickdriven and they are in the process of taking the content from the one website and putting it into the new one. The new and improved website should go live in January and Dominick will present it to the board in February. Department heads will have an opportunity to edit the content shortly.

#### • 2014 Canton Woods Senior Center Agreement

The mayor noted that a couple of changes need to be made and once approved by the village's attorney he will sign the agreement. Once signed by the mayor the agreement will be sent to Supervisor Sykes and Supervisor Salisbury for their approval. One change is to Item #16 regarding the due date that the village treasurer needs to submit a financial report to both town comptrollers by. Instead of "no later than May 31st of each year", the village would like it to say" on or about May 31st. The other change is to Item #15 regarding the establishment of an account for the unspent funds attributable to the Towns' contributions. The verbiage should state "The Village of Baldwinsville shall account for any unspent funds..." The village treasurer has a complete record of all unspent funds but will not have them in a separate banking account.

## • Presentation by CHA – site plan for the development of the waterfront on Lock Street

Clough Harbor Associates representative James Trasher, on behalf of Fobes Island LLC., made a presentation on the adoption of a PDD located off Lock Street. Their intent is to be able to utilize the parcel for a potential mixture of apartment buildings, town homes, and apartment units in varying densities along Lock Street. The proposed project includes two 3-story apartment buildings with 26 units per building and a number of town home/apartment units each with 4-6 units per structure. Site amenities would include parking, garages, sidewalks, walking trails, landscaping, lighting, and stormwater management facilities.

This was an informational meeting with the next presentation to be given to the Planning Board for their approval.
