

**LOCAL LAW 2022- 9 - AMENDING CHAPTER 268, SECTION 268-6 ENTITLED
“COMPLIANCE” OF THE CODE OF THE VILLAGE OF BALDWINSVILLE**

BE IT ORDAINED AND ENACTED by the Village Board of the Village of Baldwinsville, County of Onondaga, State of New York, as follows:

Section 1. That Chapter 268-6. of the Code of the Village of Baldwinsville is amended as follows:

§ 268-6 Compliance.

A. Nonconforming signs.

~~(1) Any permanent sign in use of a type not permitted by this chapter at the time of adoption shall be a nonconforming use. A nonconforming sign shall not be enlarged and shall be removed if the Code Enforcement Officer declares it unsafe. The relettering, repair, painting or decorating of such signs shall be permitted, but any sign once removed for purposes other than relettering, repair, painting or decorating shall be deemed permanently removed and may be replaced only in accordance with the provisions of this chapter.~~

~~(2) In the event that a business with a nonconforming sign changes hands and the firm name changes, the signs of the replacement business must meet the provisions of this chapter.~~

(1) Notwithstanding any other provision of this chapter, any sign in existence at the date of adoption of this chapter which does not conform to the provisions of this chapter shall be discontinued and removed on or before August 1, 2025, and the failure to discontinue or remove such nonconforming sign on or before the aforesaid date shall constitute a violation of the provisions of this chapter. All nonconforming signs in the Village of Baldwinsville at the time of the adoption of this chapter may be maintained until August 1, 2025, but if any major change, modification, structural repair or replacement thereof is hereafter made, such sign shall thereafter

conform to the provisions of this chapter, provided that a legal nonconforming sign may not be replaced by another nonconforming sign.

Section 2. This local law shall take upon the filing with the Secretary of State.

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN, that, pursuant to Section 7-706 of the Village Law of the State of New York, and pursuant to resolution of the Village Board of the Village of Baldwinsville, adopted July 7, 2022, a public hearing will be held by the Village Board of the Village of Baldwinsville at the Village Hall, 16 West Genesee Street, Baldwinsville, New York, 13027, on the 21st day of July, 2022, at 7:30 P.M., to consider a proposed Local Law amending the Village Code of the Village of Baldwinsville, Chapter 268-6, providing that all non-conforming signs in existence at the time of the adoption of the current sign Code be discontinued and removed on or before August 1, 2025, and that any major modifications or changes to existing non-conforming signs requires the signs to become conforming to the provisions of the Code. A copy of the proposed Local Law may be examined by any interested party at the Office of the Village Clerk.

At the time and place of the hearing, all interested persons will be given an opportunity to be heard.
