The Pledge of Allegiance was recited.

Resolution #153/2023 Moved by Trustee O'Donnell, second by Trustee Collins Resolved that the minutes from the Village Board meeting of November 02, 2023, be approved. Carried

Citizen's Comments-Sarah Baker spoke to the Village Board regarding a proposal letter that was sent to the board to ask to move the Village elections from March to November. She stated three reasons. 1st-she was stunned by the previous 10 years voting turnout of a population of between 7,000-7,800 residents not even 2% came out to vote. 2nd-As a former history and government teacher, she believes that voting and participation are the foundation of our democracy. 3rd-What accounts for this apathy and what can we do to rectify it? Sarah has spoken to many people who do not know when the village elections are held. There is a learning deficit, and we need to figure out the problem of low voter turnout.

Trustee Reinagel asked how do we not turn the election over to bi-partisan voting. The village has never been bipartisan. Village Resident S. Patterson moved to the village 20 years ago and was an out-of-towner, she never knew when the elections were. She spoke about keeping it at a neutral level.

Resident Cindy Clarke first wished the mayor good luck in his retirement. Let's keep the village non-partisan. Let's not get lost in the shuffle of having the elections in November. Let's work on what's concerning the village at that time. Village Resident and Former Mayor of the Village, Joe Saraceni, also spoke to the board. He first wanted to thank Mayor Clarke for his service and for the Mayor's love of this Community. Mr. Saraceni spoke about his 11 years with the Village. First as a Trustee then as the Mayor for 7 years. His opinion is not changing the elections to election day. If you move the elections to November, citizens will vote with party lines. You will lose the utopia atmosphere.

Treasurer Mark Baker, speaking as a resident of the village, said the village must do a better job raising the voter turnout. There is no local paper anymore. How do we get a more informed public in the village elections? When the Trustee positions were every two years, there was an election every year. It was kept in rotation and there was more voter turnout.

Trustee's Comments

Trustee Collins thanked the mayor for helping him on the Board, and well wishes. Trustee Collins asked for an Executive session to discuss a personnel matter.

Trustee Cico-wished the Mayor good luck and also reminded everyone of the Parade of Lights on November 25th. **Trustee O'Donnell** wanted to address the election discussion. She also is discouraged by the low voter turnout. The village 100% needs to do a better job in promoting the elections. We need to improve people getting involved in local government.

Trustee Shepard also stated this election is a challenge to the entire village. The challenges of the election need to be addressed.

Trustee Reinagel said thank you to the Mayor, he really appreciates everything he has done. Trustee Reinagel spoke about the election and the difference between voting and participation. People want to know why they are voting. He concurs that the village needs to do more advertising. He is willing to write letters to the editor. Reinagel questioned "Is moving the election to November going to have the effectiveness many think it will have?"

Trustee Stebbins thanked the mayor for staying the course. He kept the village what it is.

Mayor's Comments

Mayor Clarke

- Mayor Clarke thanked everyone for the great discussion on the voting. He mentioned a Facebook comment that he saw where someone asked, Do you want Quality or Quantity in the elections. People vote because they care about the issues. Village needs to make an effort to pump up spring elections. How do we do that to make information more available to people?
- Mayor Clarke wanted to remind everyone of the Parade of Lights and the Tree Lighting on Saturday, November 25th at 5:30 pm.
- The Mayor wanted to let everyone know it has been a great privilege to represent the people of Baldwinsville. He went on to say that the Board is a great group of people that put their heart and soul into what they do. They are doing what is best for the village and he appreciates the passion from everyone.

Department Heads

Attorney Bob Baldwin discussed the election laws and what would happen with a referendum on the election laws. Mr. Baldwin presented the case of what would have to be done to get it on the ballot for March. Further research and discussion are needed before voting on any change. Bob Baldwin also wished the mayor well on his retirement. Village Clerk Jody DePaulis thanked the mayor and told him it was very nice working with him.

Treasurer Mark Baker told the board that there is an upcoming item on the agenda for the new credit card processing system for water and sewer bills. Please feel open to asking questions when it is discussed. This new system will be more efficient for the village. Mark Baker also thanked the mayor for his service and how well the village ran during the pandemic.

Senior Center Coordinator Ruth Troy wanted to let the board know that the paving on the Canton Woods walking trail will begin on Monday, November 20th. There is a craft sale happening on November 17 and 18th and also the Canton Woods Tree Lighting will be happening on December 1st. If anyone is interested in the Rescue Mission Christmas dinner, you must call by December 4th to make your reservation. Coordinator Troy wished the Mayor well and thanked him for his dedication to the community.

DPW Superintendent Chuck McAuliffe also thanked the Mayor for his service and told everyone that no one realizes the amount of phone calls that go between himself and the Mayor. McAuliffe spoke about the water break that happened last week. The water dept and DPW were out there all night and day fixing 2 breaks and a valve. There was a lot of work to get it done, but everyone worked together.

Police Chief Mike Lefancheck wanted to update everyone on the power outage that happened at the 4 corners the other day. A box truck was pulling away from the curb and caught the guide wire. This resulted in the pole coming down and causing the outage. Chief Lefancheck also spoke of a court case that was dismissed from NYS regarding an excessive force case against two Baldwinsville Police Officers. Because of the manner in which the officers conducted themselves and their body and vehicle cams, the case was dismissed. Chief Lefancheck thanked the mayor for having his heart in the village. Good things happened in the village because of him, and he made the village a better place.
