REGULAR MEETING OF THE VILLAGE BOARD OF TRUSTEES WAS HELD AT VILLAGE HALL ON OCTOBER 19, 2006, AT 7:30 P.M.

Motion #250 -

Moved by Trustee Mott seconded by Trustee Stebbins that the minutes of the meeting held October 5, 2006, be approved with corrections and the Village Clerk dispense with the reading of said minutes.

Trustee Stebbins noted that on page 2 it states that the Mayor has asked Trustee Stebbins to have an issue reviewed by the Public Safety Committee and it should be the Public Works Committee.

Citizen's Comments.

No comments.

Mayor's Comments.

Acting Mayor Presley stated that Mayor O'Hara apologized for being unable to attend tonight's meeting.

Trustees' Comments.

Trustee A. Saraceni requested that an Executive Session to discuss contract negotiations, be added to the agenda.

Trustee J. Saraceni requested that a discussion/possible action regarding the 2007 proposed budget for Canton Woods Senior Center be added to the agenda under new business.

Trustee Presley reminded everyone that the Public Safety Committee Meeting will be held on October 25, 2006, at 5:00 p.m. at the Police Department.

Department Heads.

Attorney J. C. Engelbrecht noted that there were technical revisions in cleaning up some language in the original local law within the 10 day filing period; therefore, the Village Board must have the final draft in their hands ten days before they can vote on it. The Village Clerk will mail out the final draft tomorrow and the item will be on the next meeting agenda for the Village Board to vote on. He also noted that Susan Weichert has sued the Village once again and this suit relates to the second set of tickets that were filed. The Village is asking for the case to be dismissed and for sanctions. Mr. Weichert filed papers last week for a motion to be returnable up in Rochester on the first case.

The Village Clerk noted that she has received a quote from Gatescraft to construct the display case for the original fire horn in the amount of \$397.86. Gatescraft are the contractors that built the Judge's bench. The proposed display case would be constructed from Maple stock with a ¼" tempered glass front. The unit would be 27" wide, 37" tall and 8" deep. Claude Sykes stated that the cost is under the \$500.00 limit therefore only one quote is required. The Village Clerk suggested that the unit be placed at the end of the hallway in the lobby, by her customer window, where it could be seen and no one could bump into it. The only other location could be between the men's and ladies' restroom in the lobby. It was noted that a plaque would be needed to explain the history of the fire horn system. Deputy Mayor Presley stated that this is an issue that the Village Board could think about for a while before taking any action right now.

Pending Business.

Discussion/Possible Action in regards to Village Owned Facilities/Business District Study.

Trustee J. Saraceni noted that at the last Public Works Committee meeting some ideas were discussed for the area of the former Harrington Fire Station, but it was hard to visualize with the existing building still standing. The Board discussed some options regarding Denio Street as to whether to extend it further into the parking lot. Trustee Stebbins reminded the Village Board that the issue is to be on the November 16, 2006, meeting agenda for a serious discussion.

Discussion in regards to updating the Village Code.

Trustee Mott stated that there was nothing new to report.

Discussion/Action regarding the hours of operation, music, alcoholic beverages and fireworks, as they relate to Paper Mill Island.

Deputy Mayor Presley noted that he has submitted the revised copy of the Paper Mill Island Contract that was done by Linda Ross and him. He noted that the Village Board could discuss or adopt this proposed contract.

Trustee Stebbins questioned some areas of the contract, such as how no fishing was allowed whether an event was taking place or not. Another area of concern was who had control of the docking surrounding Paper Mill Island. He also questioned whether the noise levels listed are what was the last adopted. He wondered what portion of the security deposit would be held if there was a breach of contract with the exclusive pouring rights for Pepsi.

There was also a question regarding the parking in the Village's lots in front of the Red Mill Inn. Does the person or promoter of an event have control of that parking area during a rented event or is it open parking to the public.

Deputy Mayor Presley stated that he would work with Linda and work on these concerns and come back with another proposal.
