Citizen's Comments

Nancy Howe spoke on behalf of the Greater Baldwinsville Chamber of Commerce regarding the Big Chill event scheduled to be held January 20, 2018, from 12:00 p.m. to 3:00 p.m. The Rotary is working with them as well. She asked that they have permission to reserve Mercer Park and work with the village as they have in the past for this event. They will need to arrange to reserve for the event January 19, 2018-January 21, 2018.

She gave some information from last year, where 96 plungers were registered, about 325 attended in the tent and about 350 participated in the pub crawl. Sean Becker who represented the Rotary Club spoke about how they use the funds that are raised. Nancy also spoke about how the Chamber uses the funds that are raised. At the next meeting, when the paperwork has been submitted for the park use, the request will be made for the Open Container Law.

Nancy mentioned the upcoming Small Business Saturday, which is to be held November 25, 2017. It will be before the Christmas Tree Lighting, with all participants being drawn to Baldwin Canal Park for the tree lighting at the end. Also, the "Bee Local" campaign has kicked off, to promote and encourage buying locally.

Ryan Hulchanski spoke next regarding his Eagle Scout Project. It is a monument to be placed over on Marble Street on the riverbank to honor first responders. He would like the board's approval to start the project. He showed the board an actual small-scale version of the monument. Steve Darcangelo spoke and said that the site is near another memorial on the riverbank and he doesn't see a problem with any future upkeep and flowers at the site. Even if the Women's Garden Club would not be able to care for it, the village could, as it is close to other areas that the village maintains.

The Mayor said that the board needs to ok the project so that Ryan can get funding for the project. He thanked Ryan again.

The Mayor asked to move up the item 'B' under new business, proclaiming Monday, October 16, 2017, Baldwinsville Wrestling Day.

The Mayor read the proclamation and introduced the audience members who were a part of the Baldwinsville Wrestling program. He explained that these teams from 1977 -1981 will be inducted into the Greater Syracuse Sports Hall of Fame on October 16, 2017. The Baldwinsville teams and wrestling program will have a reception from 2:00 p.m. to 5:00 p.m. at Pasta's on the Green in Foxfire Golf Course on Sunday, October 15, 2017.

John Pickard spoke that it was hard to believe that this great achievement was 40 years ago. The community and booster clubs deserve thanks as they kept these sports going in the time of school tax cuts, etc. They wanted to thank everyone for helping in their success as well.

Trustee's Comments

Trustee Stebbins has a concern about the use of specific LED lit message board signs and asked that a moratorium on these signs be put in place immediately to stop these signs from being ok'd for installation.

Steve Darcangelo stated that the ZBA needs to get this message as a variance has to be granted and they would be the board to do so. That board is also granting a variance based on size only and the sign has to be in compliance. Attorney Bob Baldwin said that language on the sign codes needs to be tightened up and he has suggestions. Gregg Humphrey said that the current code is from 1986 and needs revision.

Mayor's Comments

Mayor Clarke noted:

- that Brian May is looking out for us as far as the County Budget goes. Feel free to contact Brian with questions.
- that a ribbon cutting was held for the Fireside Inn that was a very classy event.
- that the World Canals Conference had ended with a dinner that was held on Paper Mill Island for the World Canals Conference organizers and their attendees and all were thrilled with our facility. He was very proud.
- that the "Church on the Island" group was very happy with their Sunday mornings this summer on PMI and will come back next year.
- that the group called Lend.edu, congratulated Baldwinsville on being the 21st best place to buy a home.
- with sadness that Tom Howard, the 'admiral' has passed away. He was a good guy and a senior center staple.

Department Heads

Treasurer Anna Custer distributed the September financials to the board. Also, budget packets will be distributed in the next few weeks.

Ruth Troy, Canton Woods Senior Center Coordinator, advised that the senior center board approved the 2018 budget and now the two town boards need to vote and approve it.

She also said that the Onondaga County office for the Aging will be holding Public Hearings for telling of upcoming plans for 2018 elder services. They are being held on October 24th at 1 p.m. at the Jordan-Elbridge Community Center and October 25th, at the Bob Cecile Community Center. The meetings are open to everyone and anyone interested should contact the office for information.

- there is going to be live music by "Bare Bones", a trombone quartet, at 3:00 p.m. on October 26, 2017.

She would also like to express her condolences to Tom Howard's family. He will be greatly missed.

Village engineer Steve Darcangelo noted that brush pick up is every week now. The DPW has finished Village Square and it is ready with a fountain and seating with a patio and new concrete. He also noted the kayak launch is ready at Community Park along with the perimeter trail-park and nature walk- which is for pedestrian traffic only.
