WHEREAS, the Village residents of the Village of Baldwinsville may desire to remove brush from their lawn areas and are unable to do so without the use of a truck for said removal, and

WHEREAS, the Village of Baldwinsville upon request by a Village resident agrees to allow said Village resident to load only brush and leaves on a Village truck, and

WHEREAS, the Village resident hereby acknowledges and agrees that said resident shall only load brush and leaves on the aforementioned Village of Baldwinsville truck and that the resident shall have no permission or right of any kind to in any way operate, move or board said truck and resident agrees to abide by all terms and conditions of said truck, and resident agrees to abide by all terms and conditions of the attached list of rules. NOW, in consideration of mutual promises herein and other good and valuable
consideration, receipt of which is hereby acknowledged, I, as resident of the Village of Baldwinsville hereby agree to hold harmless and indemnify the Village of Baldwinsville, the Mayor, any member of the Board of Trustees of the Village of Baldwinsville and/or any other employee of the Village of Baldwinsville for any and all causes of actions, suits, debts, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, controversies, agreements, promises, variances, trespasses, damages, judgments, extents, executions, claims, property damage claims, personal injury liabilities, and demands whatsoever, in law, admiralty or equity, made by myself or by any third person
that may arise as a result of the Village of Baldwinsville allowing me to use said vehicle at or near my premises located at for the aforementioned purpose.

PARK-A-TRUCK GUIDELINES AND RULES

GUIDELINES:

- 1. Release form **must** be signed before truck can be delivered. These forms are available at the Village Clerk's Office, 16 West Genesee Street, Baldwinsville, phone 635-3521.
- 2. Trucks can be left over the weekends and holidays.
- 3. This program is designed to assist Village residents in the maintenance of the homeowner's property. Large-scale tree removal projects, by contractors, shall not qualify to utilize this service. Please make arrangements with the tree removal contractor for removal of these materials.

RULES:

- 1. The **only** person permitted to sign a release form is the property owner, who shall be at least 21 years of age.
- 2. Property owner shall not direct the truck to be placed where damage can occur to buildings, shrubs, trees, flowers, driveways, walks, underground facilities, lawns, etc.
- 3. The following are the **only items** that may be placed on the trucks: leaves, grass clippings, garden vines, brush, tree limbs, shrubbery, etc. All material must be cut into six (6) foot lengths. No material shall exceed five (5) inches diameter.
- 4. No person shall be permitted to climb on any part of the truck for **any** reason. Yard waste is to be loaded by hand. Trucks cannot be loaded with any type of machine (backhoe, loader, tractor, forklift, etc.)
- 5. Debris shall not overhang the rear of the truck more than 24 inches as per New York Department of Motor Vehicles regulations.
- 6. No one is permitted to smoke within 25 feet of any truck.
- 7. The use of plastic bags is prohibited for all materials.
- 8. The following items are **not** to be deposited on the truck: building materials, tires, metals, concrete, stone, dirt, furniture, bedding, hot water heaters, appliances, etc.
- 9. Failure to comply with the rules of the Park-A-Truck program could result in the rejection of the load, which would be left for the homeowner to bring into compliance.
